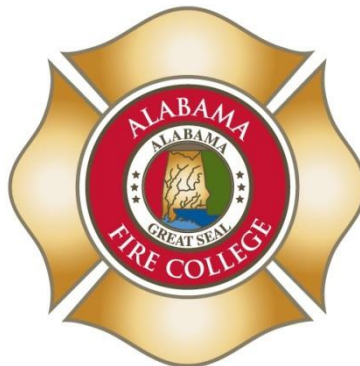

For successful completion of the practical examination, a minimum 70% competency (including critical points) is required for certification.
