Commission Work Session Meeting January 18, 2022

The meeting was called to order by Commission Chairman Joey Darby at 12:50 p.m. and was held at the Alabama Fire College in Tuscaloosa, Alabama. Proper prior notice of the meeting had been given under the Open Meetings Act.

Roll call revealed the following members present: Joey Darby, Billy Doss, Mike Green, Scott Pilgreen, Gary Sparks, Derek Toxey participating via electronic communications, and one vacant seat. (Attorney Mark Boardman) Quorum ascertained.

Chairman Darby requested an explanation of the remote session video conference. Attorney Mark Boardman stated the meeting was being conducted pursuant to Alabama Code Section 36-25A-5.1. Commissioner Toxey is attending by video conference.

MINUTES

Chairman Darby reviewed the agenda items for the Quarterly Commission meeting on January 19, 2022. It was noted that the Quarterly Commission meeting will be conducted in two separate meetings due to Commissioner Toxey being present through a remote session video conference.

Mr. Marty Lee from Jackson Thornton Certified Public Accountants presented the 2021 audit report for Commission review. He commended the staff and stated there were no findings.

Training Section Chief Arthur Willis reviewed the student training numbers which included resident, RTC, Career Tech, DOD, distance delivery and WST course offerings and certifications issued by the Fire College. Chief Willis gave updates on campus and RTC recruit schools; World Games and CTOS training in Birmingham conducted by WST, ASHER classes; CoAEMSP site visit with no citations; EMS Conference in November; EMS and Paramedic classes including the new Shelby County EMS classes; EMS Challenge; COVID testing of campus AFC students and employees; and delivery of Tempus Pro defibrillator and monitor.

Administrative Section Chief David Thornburg gave updates on the prop storage building and presented a preliminary schedule of construction from Duncan & Thompson Construction Company. The projected date given for breaking ground on the new building is April 15, 2022.

Database Specialist Tracy McNair gave an update on the Learning Management System software and department dashboard portal for the website.

Executive Director Russell discussed several matters and updates pertaining to the Fire College including but not limited to; the Learning Management System software; NIOSH report of firefighter fatality; CoAEMSP site visit report with no citations; Personnel Standards and Education Commission terms; submission of Chief Brandy Williams appointment to the Secretary of the Senate for confirmation; SCBA's received through the Assistance to Firefighter Grant; volunteer firefighter courses scheduled on the AFC campus; reinstatement of certifications revoked by the Commission in February 2020; discussion of AFG grant application for an ambulance; EMS distance delivery classes in Shelby County; firefighters responding to calls on the Alabama-Georgia border as well as the Alabama-Tennessee border; upcoming Fire Chief's Conference in Hoover; retirement of Kenny Oldfield, Linda Putnam and Cindy Woods; selection of Rudy Rooks as a full time Regional Coordinator in East Alabama; groundbreaking of the new prop storage building; request of Semmes Fire Department to become an RTC; consideration of an increase in the PPE rental rate from \$770 to \$800; discussion of the proposed changes to the Administrative Code regarding an increase in the number of training hours for Certified Career Firefighters from 360 hours to 400 hours and the Bridge Program from 200 hours to 240 hours; and the proposed addition to the Administrative Code for Certified Peer Support Member.

No action was taken on any of the above matters or any other matters.

Commissioner Green made a motion to suspend the Work Session, seconded by Commissioner Doss. The motion passed unanimously. Chairman Darby recessed the Work Session and the committee meetings convened.

Other items for consideration are related to the remote meeting format and the need for a separate meeting. The items to be addressed in a separate meeting include a public hearing to listen for comments on Administrative Code changes for Chapter 360-X-19 Certified Technical Rescue Personnel and consideration of adoption of those changes; starting the process of Administrative Code changes to Certified Firefighter under Chapter 360-X-2-.02; changes to the Administrative Code to add Certified Peer

Support Member under Chapter 360-X-28; and consideration of reinstatement of certifications of an individual that had been previously revoked. These items cannot be addressed under a remote format and therefore need to be handled in a separate meeting.

A motion was made by Commissioner Green and seconded by Commissioner Doss to approve the agenda as stated. Roll call vote was taken.

The order of speakers shall be determined by order of sign-up by issue. All speakers shall first identify themselves and whom they represent."

Chapter 360-X-19 Certified Technical Rescue Personnel

Chairman Darby called the public hearing to order and opened the floor for comments regarding the proposed changes to the Administrative Code for Chapter 360-X-19 Certified Technical Rescue Personnel.

Executive Director Russell stated there had been no public comments submitted in writing, by electronic mail, or telephone for this amendment. There were no comments from visitors. Hearing no comments, Chairman Darby declared the public hearing closed.

Commissioner Green made a motion to adopt the Administrative Code changes to Chapter 360-X-19 Certified Technical Rescue Personnel. Commissioner Pilgreen seconded the motion. Roll call vote was taken.

Chairman Darby stated the next item for consideration was Administrative Code changes to Certified Firefighter Chapter 360-X-2-.02 and asked Executive Director Russell to outline the proposed changes. Director Russell recommended an increase in training hours for Certified Firefighter from 360 to 400 hours and an increase in training hours for the Firefighter Bridge Program from 200 to 240 hours.

Chairman Darby reminded the Commission about discussion during the Work Session regarding increasing training hours and how that might also impact the need for additional tuition in the future.

Chairman Darby stated he would entertain a motion to consider beginning the process of approving changes to the Administrative Code Chapter 360-X-2-.02 for Certified Firefighter. A motion was made by Commissioner Doss and seconded by Commissioner Sparks. Roll call vote was taken.

Executive Director Russell discussed several matters and updates pertaining to the Fire College including but not limited to, discussion of the proposed changes to the Administrative Code regarding increasing the number of training hours for Certified Career Firefighters and the Bridge Program; the proposed addition to the Administrative Code for Certified Peer Support Member; releasing Public Fire and Life Safety Educator I as a field delivery course; contract and resolution with the city of Birmingham and Birmingham Fire and Rescue Service regarding paramedics for the upcoming World Games; Semmes Fire Department becoming a regional training center; modifications to our AFC physical statement form; CoAEMSP site visit report with no citations; discussion of AFG grant application for an ambulance; CFSI in Washington, DC; Fire College Weekend in Decatur; the overall growth of EMS Challenge; increase in the number of certifications issued to date in 2022 compared to 2021; upcoming SEAFC Conference, PFFA Conference, and Volunteer Fire Department Conference; possible partnership with Jefferson State Community College for their paramedic program; and IMT position specific training.

No action was taken on any of the above matters or any other matters.

Commissioner Rice presented a proposed resolution to the Commission for renaming the Alabama Fire College auditorium after Alberto C. "Butch" Zaragoza, the longest serving appointee to the Alabama Firefighters Personnel Standards and Education Commission. On a motion properly made, the proposed resolution was unanimously approved to forward to the Quarterly Commission meeting. Commission Chair Sparks stated it would be added to the agenda under New Business.

Commissioner Green made a motion to suspend the Work Session that was seconded by Commissioner Rice. Chair Sparks recessed the Work Session and the committee meetings convened.

POLICY AND PROCEDURES/BY LAWS COMMITTEE

Committee Chair Green stated there was nothing to discuss, so without objections the Policy and Procedures/Bylaws Committee did not meet.

EMS COMMITTEE

A motion to adjourn the Work Session was made by Commissioner Green and seconded by Commissioner Doss. Commission Chair Sparks, seeing there being no further business, adjourned the meeting at 4:34 pm.

Chair Sparks called the public hearing to order for the first item on the agenda and opened the floor for comments regarding the proposed changes to the Administrative Code for Chapter 360-X-2-.02 Certified Fire Fighter. Chief Jon Lord addressed the Commission and asked if this was in regard to the increase in recruit school hours. Chief Lord requested that Chief Justin McKenzie of Fultondale Fire address the matter with the Commission. Chief McKenzie questioned increasing the hours of recruit school, if there would be an increase in tuition costs, and what will be added in those hours that would benefit the departments. McKenzie expressed his concerns of added costs and hours. Chair Sparks relayed to Chief McKenzie the Commission would address the issue further during the meeting. Hearing no further comments, Chair Sparks declared the public hearing closed for the proposed changes to the Administrative Code Chapter 360-X-2-.02 Certified Fire Fighter.

Chair Sparks opened the public hearing for the second item on the agenda and opened the floor for comments regarding the proposed changes to the Administrative Code for Chapter 360-X-28 Certified Peer Support Member. Sparks also asked Executive Director Russell to outline the proposed changes. Director Russell stated there have been several classes within the state of Alabama with three primary companies teaching peer support to members of the fire service. The Fire College program managers Jim Terrell and Toby Rigsby have evaluated those programs and they meet nationally recognized standards. Russell stated ongoing effort is being made to develop our own program for the state of Alabama. State certification can be issued to those attending training if it is added to the Administrative Code. The goal and intent are to provide Peer Support training to every firefighter in the state of Alabama not only to career departments but also to volunteer departments. Hearing no further comments, Chair Sparks declared the public hearing closed for Chapter 360-X-28 Certified Peer Support Member.

Director's Report:

Training Section Chief Arthur Willis gave updates on the following: a comparison report of AFC student training numbers from the fiscal years of 2021 and 2022; an increase in the number of Career Tech, DOD, EMS, field, resident, and regional training center courses; overall increase in the number of certifications issued by eighteen percent; discussion of Workplace Safety Training and the increased number of courses taught along with additional funding for training. Chair Sparks commented on another record year for the Fire College. Commissioner Rice inquired about a detailed quarterly training report showing all courses offered at the Fire College and

requested that a copy be provided to the Commission. Executive Director Russell gave the following reports to the Commission regarding training; the EMS program had fifty-three classes and the highest pass rates in the state of Alabama for national registries in 2021; there were students from forty-nine states and Canada that received training with the Fire College last year; the regional training centers conducted 918 training courses to 11,730 students; 159 campus delivery courses to 2,953 students, and 11,750 certifications issued for the 2021 calendar year. Russell expressed how proud he was of the hard work and effort from the staff at the Fire College.

Administrative Section Chief David Thornburg gave updates on CPAT equipment; new prop storage building and Groundbreaking Ceremony; renovation of upstairs kitchen and breakroom; scholarship agreement with Shelton State Community College for employees and their dependents; parking lot project and road repair overview; and facility usage by multiple outside agencies.

Executive Director Russell discussed several matters and updates including requests from fire chiefs to release Public Fire and Life Safety Educator I as a field delivery course along with a recommendation to approve this change; a resolution and contract with the City of Birmingham to help provide paramedics during the World Games; discussion and recommendation for Semmes Fire Department to be considered as a regional training center in Mobile County; and a recommendation to approve changes needed to the Alabama Fire College Physical Statement form.

Commissioner Rice made a motion to approve releasing Public Fire and Life Safety Educator I as a field delivery course. Commissioner Toxey seconded the motion. Roll call vote was taken.

Birmingham Fire and Rescue has a limited number of paramedics and therefore requested assistance from the Alabama Fire College to obtain additional paramedic staffing for the event.

WHEREAS, Alberto C. "Butch" Zaragoza served as a member of the City of Vestavia Hills Fire Department for 39 years, and

WHERAS, Zaragoza rose to the rank of Fire Chief and served the final ten years of his career leading the organization, and

WHEREAS, following his retirement from the fire department in 2008, Zaragoza was elected Mayor of the City of Vestavia Hills and served two full terms, and

WHEREAS, Zaragoza was appointed to the Alabama Firefighters Personnel Standards and Education Commission and provided strong leadership during the most difficult period in the organization's history, and

WHEREAS, Zaragoza was subsequently reappointed to multiple terms by three different Governors of the State of Alabama, who represented both major political parties, and

WHEREAS, Zaragoza served a total of sixteen years as a commissioner, and is believed to be the longest serving appointee in the history of the Personnel Standards Commission, and served multiple years as the Chairman of the Commission, and

WHEREAS, Zaragoza later returned to serve for a period of six months as the Interim Executive Director of the Alabama Fire College and Personnel Standards and Education Commission,

NOW THEREFORE BE IT RESOLVED, by the Alabama Firefighters Personnel Standards and Education Commission, duly assembled on this date in Tuscaloosa, Alabama and with a quorum present, that the auditorium facility on the campus of the Alabama Fire College is hereby to be named and known as the "Alberto C. 'Butch' Zaragoza Auditorium" in recognition of his long years of exemplary service to his community, the State of Alabama, and the Alabama fire service, and that an appropriate visual designation be affixed such that all who are present may know of this honor.

Commissioner Green seconded the motion. Roll call vote was taken.

Chief Lord presented a letter requesting this consortium become a regional training center.

Senator Gerald Allen addressed the Commission and gave an overview of the legislative session, the needs of the Fire College, and the upcoming construction of Highway 69 that may cause traffic issues for students at the Fire College beginning in 2023.

Chair Sparks expressed appreciation to Senator Allen for all that he has done for the Fire College over the years since he has served on the Commission. Sparks stated that Senator Allen has been a friend to the Fire College and he is appreciated.

Executive Director Russell expressed his appreciation to Senator Allen for his efforts to provide additional funding to the Fire College. Russell stated that Senator Allen has taken care of the Fire College and appreciated all his support.

Chief Joey Darby expressed appreciation for the approval of Semmes Fire Department as a regional training center and encouraged the Commission to consider future similar approvals. Chief Darby stated it was an honor serving with Commissioner Green for many years on the Commission, wished him well, and appreciated what he had done for the fire service. Darby also expressed appreciation to Senator Allen for his assistance with funding for the Fire College.

Commissioner Rice thanked Senator Allen and those behind the scenes for their support of the Fire College.

Josh Bryant addressed the commission and stated he was encouraged by the Commissioners serving on the Board, their involvement, and their support of promoting training in the fire service in Alabama. Bryant updated the Commission on two bills that were passed in the last legislative session to help those in the fire service. The first bill was retroactive approval providing a death benefit to first responders for COVID-19 related deaths. The second bill was an annual income tax credit for certain active firefighters and paramedics who receive certain types of training. Bryant also encouraged the Commission to continue supporting the promotion of additional training to give all those wanting training the opportunity to do so.

BUSINESS FROM COMMISSION MEMBERS

There was none.

Commissioner Green made a motion to suspend the current meeting until after the Groundbreaking Ceremony for the new prop storage building. Commissioner Toxey seconded the motion. The motion passed unanimously. Chair Sparks suspended the meeting at 10:16 am.

ORIGINAL MEETING RECONVENES

Commission Chairman Sparks called the Quarterly Commission meeting back to order at 11:54

PUBLIC HEARING FOR DISCIPLINARY MATTERS

The next matter to come before the Commission was a public hearing. Commissioner Toxey recused himself from deliberations. De'Angelo Davis was appealing the recommendation of discipline by Executive Director Russell. A two-year suspension of certifications issued by the Alabama Fire College was imposed against Mr. Davis for academic fraud. Davis was appealing the discipline imposed by Director Russell because he felt it was overly excessive. Commission Attorney Mark Boardman presented the charges.

Mr. Boardman demonstrated that Mr. Davis received proper notice of the charges and of today's hearing in letters delivered by certified mail. These letters were dated December 6, 2021, February 4, 2022, and March 11, 2022.

Attorney Daron Drew and LaTonya Mines represented De'Angelo Davis at the hearing. Ms. Drew presented the case for De'Angelo Davis to the Commission.

A court reporter from Bain and Associates Court Reporting Service, Inc. 505 20th Street North, Suite 1250, Birmingham, AL 35203 recorded all the testimony and proceedings.

All other Commissioners adjourned to a private room for further discussion and deliberation. At the conclusion of deliberations, the Commissioners returned and Chair Sparks called the meeting back to order. Chair Sparks stated that the Personnel Standards and Education Commission voted 6 votes in favor with 1 recusal to uphold the recommendation and discipline invoked by Executive Director Russell with no further punishment against De'Angelo Davis. The discipline included revocation of the following certifications issued by the Alabama Fire College and Personnel Standards and Education Commission for a period of two years: Hazardous Materials Technician, Fire Instructor I, Fire Instructor II, Fire Officer I, Fire Officer II, Fire Inspector I, Fire Department Incident Safety Officer. Mr. Davis will be allowed to petition the Commission for reinstatement of the revoked certifications at the end of the two-year period.

The Commission agreed more marketing of the fire and EMS services was needed throughout the state.

Commissioner Doss announced the upcoming Annual AAVFD Conference in Sheffield, July 8-9, 2022. Chairman Sparks announced the upcoming Southeastern Association of Fire Chief's Conference in Mobile, June 21-24, 2022.

Chair Sparks stated the next Work Session will be July 19, 2022. The next Quarterly Commission meeting will be July 20, 2022.

Commissioner Toxey made a motion to adjourn the meeting that was properly seconded. Without objection, the meeting was adjourned at 1:16 p.m.

Special Called Commission Meeting June 30, 2022

The meeting was called to order by Chair Gary Sparks at 9:11 am and was held at the Alabama Fire College in Tuscaloosa, Alabama. Proper prior notice of the meeting had been given under the Open Meetings Act.

Chair Sparks stated the meeting was initially intended to be a committee meeting. A committee was appointed by the Commission to research the proposal of increasing recruit school training hours. David Thornburg, Johnnie Phelps, Jeff Waldrop, Michael Bartlett, Charles Parsons, Justin McKenzie, Alex Nabors, Josh McDaniel, Rick Gregg, Nathan Hinds, Tracy McNair, Kim Davis, Adam Whatley, Chase Smith, Arthur Willis, Josh Bryant, Christian Elliott, Cece Hubbert, and Reid Vaughan.

MINUTES

Chair Sparks stated he would entertain a motion to go into Work Session. Commissioner Toxey made the motion that was seconded by Commissioner Rice. Motion carried.

Executive Director Russell stated the proposal to increase training hours was not a new request and was due to changes in the NFPA standard. An overview timeline of NFPA standard changes and training hours was presented to the Commission. There have been seven NFPA standard changes since 1981. It has been 17 years since the number of training hours have been increased for recruit school. AFC staff and training instructors throughout the state have stated for several years that more than nine weeks is needed to complete recruit school training. Russell stated his request to increase training hours was based on their feedback.

Adam Whatley, lead instructor of AFC recruit school, addressed the Commission and presented the following justification for increasing training hours to ten weeks: the addition of Rapid Intervention Crew Member; the addition of multiple chapters in the Essentials of Fire

Fighting, Seventh Edition; an increase in the number of slides from 1,680 to 2,893; First Aid Provider on the first day of recruit school; drug testing of all self-sponsored students on the first day; SCBA fit test for all self-sponsored students; washing turn out gear bi-weekly for the overall health and safety of the student, and students request for more time on the drill field.

The Commission discussed several matters with AFC staff and visitors pertaining to firefighter programs including but not limited to; changes in the NFPA standard; the request to increase training hours for recruit school; consider making First Aid Provider a prerequisite for recruit school but still meet the standard; Volunteer Fire Fighter 160; Bridge program; high school program; Career Tech program; reciprocity; recertification; locations of Bridge programs; survey from training officers; survey from volunteer fire departments; Rapid Intervention Crew Member and HazMat Awareness and Operations being taught in recruit school; minimum standard for certification; recruit training at regional training centers; field delivery training; recruit training for self-sponsored students; NIOSH report of line of duty death; work force issues; possible block system training program; CPAT; physical statements; and creating options for recruit training programs.

Commissioner Rice requested the Chair of the Commission restate the charge of the committee. Work of the committee involves any initial training and certification requirements as well as work force development issues for the fire service. Chair Sparks expanded the scope of the committee to deal with all things Fire Fighter training, Volunteer Fire Fighter 160, recruit school, reciprocity, recertification, bridge program, high school program, Career Tech program, and entry requirements. Sparks stated basically anything that touches how you become a firefighter in Alabama.

Chair Sparks requested further information from Executive Director Russell and AFC Staff to be presented at the next Commission meeting on the following topics; implementing a block system format for recruit training; what is required by the NFPA standard; process for reciprocity, record of reciprocity applications and how many have been approved; a plan for the high school programs to help fill the bridge classes; communication with volunteers and volunteer fire departments regarding the bridge program; answers regarding retesting Fire Fighter I in the bridge program; and training requirements for recruit schools in other states.

Executive Director Russell stated Dr. Esco will be attending the next Work Session. Dr. Esco wrote the recruit exercise program for the Fire College. Russell also informed the Commission about 600 yards of concrete that was poured at the new prop storage building. All Commissioners were invited to tour the grounds.

Chair Sparks recognized Commissioner Billy Doss for receiving the well-deserved award for Volunteer Fire Chief of the Year. Sparks thanked all those in attendance and stated how much the Commission appreciated their input.

The next Work Session will be on July 19, 2022 at 12:30 p.m. The next Quarterly Commission meeting will be on July 20, 2022 at 9:00 a.m.

Commissioner Doss made a motion to adjourn the meeting that was seconded by Commissioner Toxey.

Without objection, the meeting was adjourned at 12:28 pm.

MINUTES

BUSINESS FROM COMMISSION MEMBERS

WHEREAS, harassment, intimidation, the creation of a hostile work environment, and discrimination are prohibited under certain federal and state laws; and

WHEREAS, pursuant to Alabama Code 13A-11-8, a person commits the crime of harassment if, with intent to harass, annoy, or alarm another person, he or she directs abusive or obscene language towards another person; and

WHEREAS, Alabama law considers harassment to be a Class C misdemeanor; and

WHEREAS, under federal law, harassment may also be a form of employment discrimination that violates Title VII of the Civil Rights Act of 1964, the Age Discrimination in Employment Act of 1967. (ADEA), and the Americans with Disabilities Act of 1990, (ADA); and

WHEREAS, said laws exist for various reasons, including but not limited to, promotion of public order and civility, and prohibition of objectively offensive behavior; and

WHEREAS, the Commission desires adherence to applicable federal, state, and local laws by all persons under its authority; and

WHEREAS, the Commission has also implemented Policy No. 620.01 which provide employees additional recourse for any workplace grievance that may be considered harassment; and

WHEREAS, the proscribed conduct unjustifiably affects other individuals adversely, thereby limiting those individuals; ability to perform to the utmost of their personal and professional potential; and

WHEREAS, the Commission denounces this behavior and prioritizes the abolition of the same.

NOW THEREFORE BE IT RESOLVED by Alabama Firefighters' Personnel Standards and Education Commission, duly assembled on this date in Tuscaloosa, Alabama and with a quorum present, that the conduct described above and adjudged in violation of applicable law, is unacceptable and shall not be condoned or facilitated by the Commission and persons under its authority.

Commissioner Doss made a motion to approve the resolution that was seconded by Commissioner Bryant.

Motion passed unanimously.

Commission Chair Sparks stated the next item of Business from Commissioners is the Executive Director Performance Appraisal Evaluations. Commission Chair Sparks stated the performance appraisal evaluation process was reviewed by Attorney Mark Boardman. Commissioner Pilgreen made a motion to extend the Executive Director's contract by one year and to authorize Commissioner Sparks to sign such. Commission Chair Sparks provided clarification that a one-year extension of Director Russell's contract will go through the second quarterly meeting of 2024. Commissioner Toxey seconded the motion.

MINUTES

Commission Chair Sparks reviewed the agenda items for the Quarterly Commission meeting on October 19, 2022.

Training Section Chief Arthur Willis presented the training report to the Commission comparing classes from the 2020-2021 fiscal year to the 2021-2022 fiscal year. The report showed an increase in the number of training classes offered through Career Tech, DOD, EMS, field, and at the regional training centers. However, there was a slight decrease in the distance learning classes, EMS field classes, resident classes, and Workplace Safety classes. Overall certifications issued to date have increased by 15 percent. Chief Willis gave updates on ongoing and upcoming recruit schools and bridge programs; EMS and Paramedic classes; the EMS Conference to be held in Orange Beach; EMS Challenge; and promotional testing.

Commissioner Rice inquired about the distance delivery classes being offered by the Fire College. Executive Director Russell provided further information regarding past experiences with distance delivery classes, classes currently offered, and future plans for those classes.

Administrative Section Chief David Thornburg discussed the AMAS Incident Management Team full scale exercise that took place on campus October 10th through October 12th.

Participation involved 39 agencies and 195 personnel. Stentsen Ellenburg was recognized for his hard work as IMT Commander during the exercise. Commissioner Williams commended the AFC as well as the IMT staff and stated that it was great training. Further information was given about six ongoing position specific training classes taking place over the next month. Chief Thornburg gave updates on the construction and completion dates of the prop building as well as an investigation into alleged false documentation presented by a student.

Regional Section Chief Reid Vaughan gave updates on hiring Jason Brannan as a mechanic and mobile prop driver/operator, EMT tuition waivers awarded throughout the state; Hurricane Ian relief briefings; thirteen fallen firefighter names that were honored for their service and sacrifice at the Firefighter Memorial service held on October 1st; future improvement plans for the Firefighter Memorial through the Joint Fire Council; and Public Fire and Life Safety Educator course being released to field delivery.

Database Specialist Tracy McNair gave updates on the Learning Management System software and department dashboard portal of the website. McNair outlined the ease of access and the increased department use leading to an increase in the number of roster changes and registrations.

Director Russell stated the goal of the department dashboard portal is to give the departments and firefighters better access to their information.

Executive Director Russell presented his report discussing several matters and updates pertaining to the Fire College including but not limited to, AFG Grant application to purchase two driving simulators, two pump simulators, and a trailer for transporting one set of simulators throughout the state; AFG Grant and additional funding needed for the purchase of an ambulance; financial support from the Alabama Department of Mental Health for the Peer Support program; discussions with Dr. Kerry Ramella for developing comprehensive peer support curriculum; financial support from the Joint Fire Council to help offset the cost of peer support curriculum development: ACCS/Volunteer Rescue Squad EMS tuition reimbursement program; mobile training tower damage and cost of repairs; Anniston RTC recruits attending HMAO training at the Center for Domestic Preparedness facility; meeting with Dr. Esco and colleagues from the University of Alabama regarding research during recruit training; meeting with State 911 Board regarding HB 414 and discussions involving Public Safety Telecommunicator course training; 2022 North American Fire Training Directors Conference; Colbert County Volunteer Firefighters Association banquet; an increase in certifications issued in 2022; update on the purchase of inflatable rubber boats, motors, and trailers; Pipeline and Hazardous Materials Safety Administration awarded AFC a Pipeline Emergency Responders Grant for training emergency responders in the state of Alabama; developing an electric vehicle response program in the future; and the Chief Butch Zaragoza plaque for the auditorium dedication ceremony.

Commission Chair Sparks, Commissioner Rice, and Commissioner Bryant discussed the need for a protocol policy on usage of our mobile training towers at any facility. A request was made for a proposal of usage policy to be presented at the next Commission meetings in January 2023.

No action was taken on any of the above matters or any other matters.

The Work Session was suspended at Commission Chair Sparks discretion, without objection.

FINANCE COMMITTEE

Finance Committee Chair Brandy Williams called the Finance Committee meeting to order. All commissioners were present. Chief Financial Officer, Cece Hubbert, presented the August 2022 Financial Statements.

Committee Chair Williams discussed several items with the Commission including the August 2022 financial statements; applying for an AFG grant for driving simulators, pump simulators and trailer for transporting with grant match approval; mobile training tower repairs; additional expenditures for ambulance purchased through the 2021 AFG grant; HMEP Grant; and rollover budget expenditures.

On motions properly made and seconded, the Finance Committee unanimously approved motions concerning each of these items to forward to the Quarterly Commission meeting.

EMS COMMITTEE

Committee Chair Toxey commended Director Russell, Chief Willis, and Bailey Price for their hard work in the EMS Program. Chair Toxey stated there was no further business and, without objection, adjourned the meeting.

FIREFIGHTER PROGRAMS

The Firefighter Programs Committee meeting was called to order by Commission Chair Sparks. All commissioners were present. Recruit School, Volunteer 160, and Career Tech/Firefighter Bridge programs were discussed. Executive Director Russell gave a comparison evaluation of our programs to the NFPA standard. The Commissioners discussed the differences in Volunteer 160 and Bridge programs, the number of certifications currently received during recruit school

training, locations of the Bridge programs, the possibility of removing the requirement for Bridge programs to be taught at our regional training centers, responsibilities of the Regional Coordinators, the minimum requirements to be employed as a firefighter, physicals, and the need for further discussion regarding SCBA week. No action was taken.

There being no further business, Commissioner Sparks adjourned the Firefighter Programs Committee meeting and returned to the Work Session.

NEW BUSINESS

Commission Chair Sparks requested further information regarding the Administrative Code changes to Certified Technical Rescue Personnel: Watercraft Rescue. Director Russell stated the change was a prerequisite of Surface Water and possess a valid vessel operator license.

BUSINESS FROM COMMISSION MEMBERS

Matt Adams with Raymond James Public Finance Investment Strategies Group addressed the Commission and presented information about tailoring an investment plan to help manage the reserve funds for the Fire College. Commission Chair Sparks requested Mr. Adams coordinate with the Chief Financial Officer and present a report to the Commission at the January Commission meeting.

General Paul Pocopanni with the Folds of Honor organization addressed the Commission and provided further information regarding a scholarship program for families of fallen warriors including law enforcement and first responders.

Commissioner Bryant inquired about the Legislative Affairs contract. No action was taken.

A motion was made by Commissioner Toxey and seconded by Commissioner Pilgreen to adjourn the Work Session. Commission Chair Sparks, seeing there being no further business, adjourned the meeting at 4:20 pm.

Director's Report:

Section Chief Arthur Willis presented the Training Report to the Commission. Chief Willis reported an increase in Career Tech, DOD, EMS, Field, Industrial, Partnership and Regional Training Center courses. However, Distance Learning, EMS Field, Resident and WorkPlace Safety Training courses had slight decreases over the last quarter. There was an increase in the number of students and certifications issued increased by 15 percent. Willis gave an overview of all current and upcoming recruit schools, EMS and Paramedic classes, participation in West Alabama Worlds of Work held at Shelton State Community College, and promotional testing.

Section Chief David Thornburg presented the Administration Report to the Commission. Chief Thornburg gave an overview of the IMT full scale exercise held on the AFC Campus in which 39 agencies and 195 personnel were involved.
